

Furman University, a Corporation, its successors and assigns, forever:

All that piece, parcel or lot of land in Greenville County, State of South Carolina, lying and being in the City of Greenville on the South side of University Ridge (formerly known as Choice Avenue) and being known and designated as Lot No. 5 of the Furman University Property as shown on a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "A", Page 415 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of University Ridge (formerly Choice Avenue), joint front corner Lots Nos. 4 and 5, which iron pin is also 258.75 feet West of the Southwest corner of the intersection of University Ridge and Judson Street and running thence with the line of Lot No. 4 due South 250 feet to an iron pin in the line of Lot No. 12; thence with the line of Lots Nos. 12 and 11, N. 89-40 W. 80 feet to an iron pin joint rear corner Lots Nos. 5 and 6; thence with the line of Lot No. 6 due North 250 feet to an iron pin on the South side of University Ridge joint front corner Lots Nos. 4 and 5; thence along the South side of University Ridge, S. 89-40 E. 80 feet to the beginning corner.

The above described property is the same conveyed to Belle H. Calvert by Herbert W. Provence and Mary Hall Provence by deed dated February 28, 1938 and recorded in the R. M. C.
