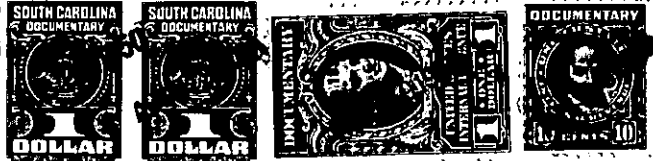

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. L. Jordan and Hattie C. Jordan, their heirs and assigns:

ALL that certain lot of land in Paris Mountain Township, Greenville County, State of South Carolina, on the Northern side of Long Forest Drive, being known and designated as Lot No. 20 on Plat of the property of Nabors and Bridges, recorded in Plat Book 0, at page 195 and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Long Forest Drive, at joint front corner of Lots Nos. 19 and 20, and running thence with line of Lot No. 19, N. 0-15 E. 359 feet to an iron pin; thence due West 150 feet to an iron pin at rear corner of Lot No. 21; thence with line of Lot No. 21, S. 0-15 W. 358.4 feet to an iron pin on Long Forest Drive; thence with the Northern side of Long Forest Drive, S. 89-45 E. 150 feet to the point of beginning.

This property is subject to restrictions recorded in Deed Book 396 at page 112. The above described property is the same as conveyed to the Grantors herein by deed of W. F. Nabors and R. L. Bridges by their deed dated the 2nd day of December, 1949 and recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 406 at page 102.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
