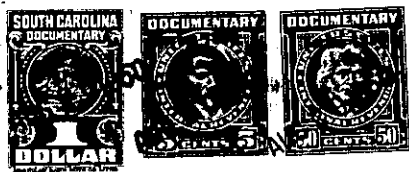
O. A. Hughes, his heirs and assigns forever:

Beginning at an iron pin on the East side of Sutton Drive, at the joint front corner of lots Nos. 24 and 25 of Block "C" and running thence with line of lot 24, N. 80-17 E. 150 feet to an iron pin; thence S. 9-43 E. 70 feet to an iron pin, corner of lot No. 27; thence with line of lot No. 27, S. 80-17 W. 150 feet to an iron pin on Sutton Drive, thence with Sutton Drive, N. 9-43 W. 70 feet to the point of beginning.
