in consideration of the sum of One Thousand and No/100 (\$1000.00)----- DOLLARS,

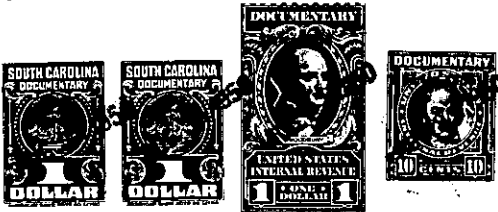

J. Riddle, August 16, 1950, as follows:
