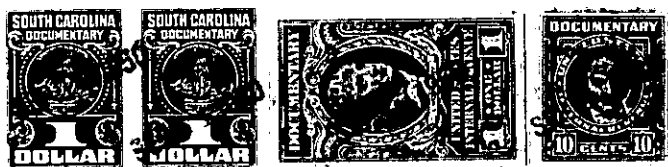
OLLIE FARNSWORTH R.M.C. Know All Men by These Presents:

That Larthun Durham in the State aforesaid, in consideration of the sum of---Nine Hundred Fifty and No/100 (\$950.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIE R. DURHAM, his heirs and assigns, all that certain piece, parcel or tract of land in the County of Greenville, State of South Carolina, in Butler Township, containing 1.2 acres, being a portion of the J. A. Bull property, plat of which is recorded in Plat Book "L", at page 103, and having according to a more recent plat made by J. Mac Richardson, Surveyor, the following metes and bounds, to-wit:

BEGINNING at a pin in a County Road and running thence along the center of a private road N. 33-16 E. 185 feet to a pin; thence continuing along said private road N. 58-54 E. 173 feet to a pin; thence continuing along said private road N. 35-04 E. 107.5 feet to a pin; thence S. 14-08 E. 268.8 feet to an iron pin; thence S. 84-16 W. 170 feet to an iron pin on the edge of the County Road; thence continuing into the said County Road to a pin S. 84-16 W. 125.6 feet; thence continuing through the center of said County Road S. 63-47 W. 93 feet to a pin, the point of beginning; being 1.2 acres located in the Southwesterly corner of the property of Larthun Durham.

This is a part of a tract of land containing 97.65 acres, property of Larthun Durham and conveyed to him by J. A. Bull by deed dated September 18, 1941, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deeds Volume 237, page 303.
