FIRST: Their names and residences are as above given.

SECOND: The name of the proposed Corporation is FOUNTAIN INN LODGE NO. 192 A. F. M.

THIRD: The place at which it proposes to have its headquarters or be located is FOUNTAIN INN, S. C.

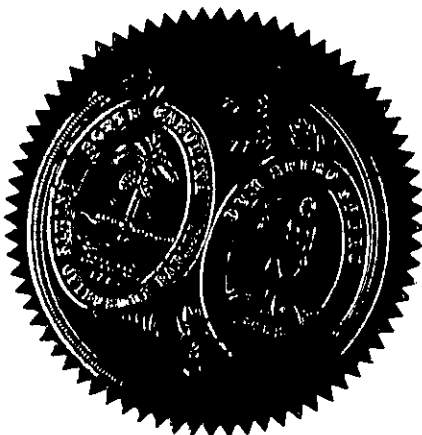
FOURTH: The purpose of the said proposed Corporation is fraternal and charitable
