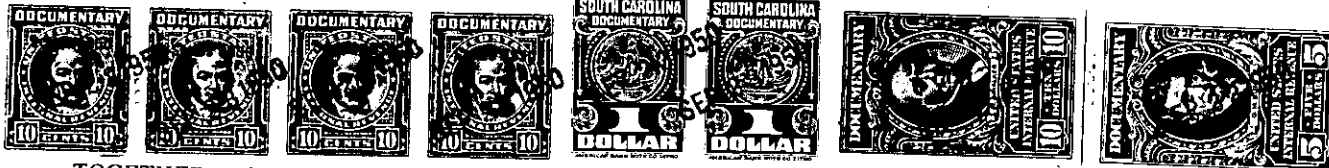
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

A. M. MOSELEY, his heirs and assigns, all that piece, parcel or lot of land, situate, lying and being on the Northerly side of Longview Terrace in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #10, Forest Heights, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book P, page 71, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northerly side of Longview Terrace, joint front corner Lots #9 and #10, which iron pin is 881 feet from an iron pin in the Northeastern intersection of East Faris Road and Longview Terrace, and running thence N. 26-55 E. 165.0 feet to an iron pin, joint rear corner Lots #9 and #10; thence through the center of a 10-foot reservation for utilities S. 65-45 E. 70.1 feet to an iron pin, joint rear corner Lots #10 and #11; thence S. 26-55 W. 168.3 feet to an iron pin on the Northerly side of Longview Terrace; thence along the Northerly side of Longview Terrace N. 63-05 W. 70.0 feet to an iron pin, the point of beginning.
