NOW, Therefore, Know all Men by these Preesents, that I, E. INMAN, Master, in and for the County  
of Greenville aforesaid, by virtue of the aforesaid decree, upon receipt of \$437.50

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release  
unto the said Jack K. Wherry and Elizabeth F. Wherry,

All the right, title and interest of the Defendant, Essie Hulsey, the  
same being an undivided one-half interest in and to the following de-  
scribed real estate: All that piece, parcel or lot of land in Green-  
ville Township, Greenville County, State of South Carolina, known as  
Lot No. 7 in Glenn Grove Park, according to plat recorded in the R. M. C.  
Office for Greenville County in Plat Book F, page 233, and having the  
following metes and bounds, to-wit:

BEGINNING at an iron pin on Coolidge Ave., interesecting corner of Lots  
Nos. 6 and 7 and running thence S. 74-12 E. 199 feet to an iron pin;  
thence S. 47-50 W. 59 feet to the corner of Lot No. 8; thence N. 74-12 W.  
along the line of Lot no. 8, 167.7 feet to an iron pin on Coolidge Ave.;  
thence N. 15-48 E. along Coolidge Ave., 50 feet to the beginning corner.
