Graydon and Jewel V. Graydon, their heirs and assigns forever,

All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 97, on the plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

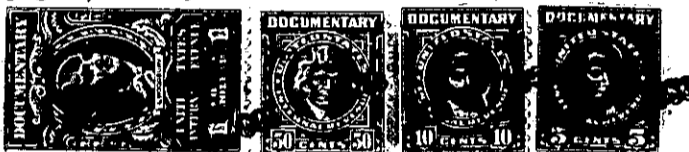
BEGINNING at an iron pin on the northern side of Bradley Boulevard at the joint front corner of Lot Nos. 96 and 97 and running thence with the joint line of said lots N 37-34 W 182.5 feet to an iron pin, joint rear corner of Lot Nos. 96, 97, 117 and 118; thence along the joint rear line of Lot Nos. 97 and 117, S 52-26 W 75 feet to an iron pin on the eastern side of Beverly Lane; thence with the eastern side of Beverly Lane S 37-34 E 182.5 feet to an iron pin on the northern side of Bradley Boulevard at the intersection of said boulevard and Beverly Lane; thence with the northern side of Beverly Lane N 52-26 E 75 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
