Know All Men by These Presents:

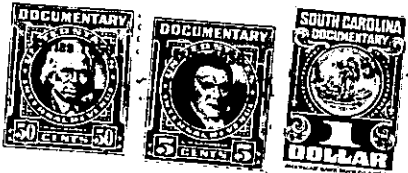
That I, L. E. Arnold in consideration of the sum of Three Hundred and No/100 (\$300.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Bernice J. Bolding, her heirs and assigns, forever,

ALL that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, on the Northwest side of Hallton Road, and being known and designated as a part of Lot No. 5 of a subdivision known as Happy Valley Farms, as shown on Plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "O" at Page 103, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Hallton Road at the corner of Lot No. 6, and running thence along the Northwest side of Hallton Road N. 33-22 W., 80 feet to an iron pin on Gladys Drive; thence along Gladys Drive N. 56-30 W., 260 feet, more or less, to an iron pin; thence S. 33-15 W., 80 feet to an iron pin at the rear corner of Lot No. 6; thence along the line of Lot No. 6, S. 56-30 E., 260.2 feet to the beginning corner.
