All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 18, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of U. S. Super Highway No. 29 at the joint front corner of Lot Nos. 17 and 18 and running thence with the joint line of said lots N 37-34 W 200 feet to an iron pin on the Southern side of a 20 foot alley; thence with said alley S 52-26 W. 100 feet to an iron pin, joint rear corner of Lot Nos. 18 and 19; thence with the joint line of said lots S 37-34 E. 200 feet to an iron pin on the Northern side of said U. S. Highway No. 29; thence with said Highway N 52-26 E 100 feet to the point of beginning.
