All those lots of land in Chick Springs Township, Greenville County, State of South Carolina, situate on the Eastern side of Rose Garden Street, and being shown as Lots Nos. 39, 40, 41, 42, 43 and 44 of Block D on Plat of Buena Vista, recorded in Plat Book W at Pages 11 and 29, and when described together have the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Rose Garden Street at the joint front corner of Lots Nos. 38 and 39, and running thence with the line of Lot No. 38, N. 80-17 E. 150 feet to an iron pin at the rear corner of Lot No. 21; thence with the rear line of Lots Nos. 21, 22, 23, 24, 25 & 26, 210 feet to an iron pin at the rear corner of Lot No. 45; thence with the line of Lot No. 45, S. 80-17 W. 150 feet to an iron pin on Rose Garden Street; thence with the Eastern side of Rose Garden Street, N. 9-43 W. 210 feet to the point of beginning.
