is hereby acknowledged), have granted, sold and released, and by these presents do grant, sell and release unto

J. S. HENSON all that piece,
parcel or lot of land in Chick Springs Township, Greenville County, S. C., being
known as Lot 15 of Addition to Pinehurst Subdivision as shown on a plat
by W. N. Willis, Civil Engineer, dated September 10, 1949, and having the
following metes and bounds; beginning at an iron pin on Hazel Drive at the
joint corner of Lots 14 and 15 of said Addition, and running S. 12' 15" E.
81.5 feet to the joint rear corner of said Lots; thence N. 64' 33" W. 150
feet to an iron pin; thence N. 25' 58" W. to an iron pin on Hazel Drive;
thence N. 99' 36" E. along Hazel Drive 135 feet more or less to the begin-
ning point.
