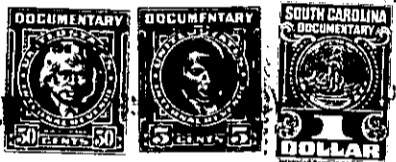
That I, H. W. Abbott in the State aforesaid,
