Know All Men by These Presents:

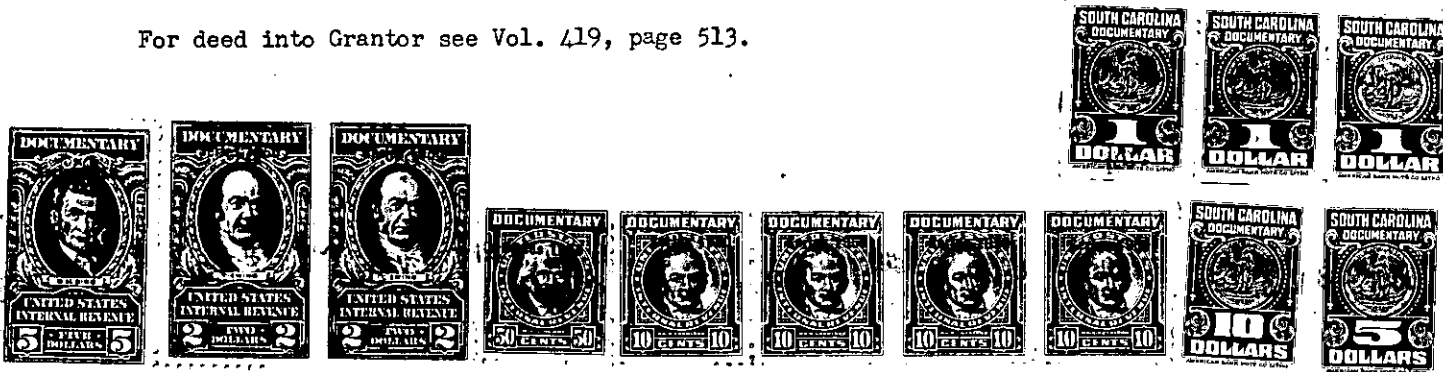
That William A. Lynch in the State aforesaid,

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Westerly side of Oakview Drive in the City of Greenville, South Carolina, and being shown as Lot No. 13 on the Plat of the Property of Edgar Odom recorded in the RMC Office for Greenville County, S. C., in Plat Book "Z", page 73, and having according to said plat the following metes and bounds, to-wit:
