O. Rhodes and Doshie W. Rhodes, and their heirs and assigns, forever.

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known and designated as Lot No. 23 on plat of Druid Hills, recorded in the R. M. C. Office for Greenville County in Plat Book "P" at page 113, said lot being more particularly described as follows:

BEGINNING at an iron pin on the South side of West Fair View Avenue at joint front corner of lots #22 and 23 and running thence with line of lot #22, S 48-11 W 208 feet to an iron pin; thence S 71-54 E 107.3 feet to an iron pin, corner of lot #24; thence with line of lot #24, N 33-05 E 168 feet to an iron pin on West Fair View Avenue; thence with the southern side of said Avenue N 49-06 W 50 feet to the beginning corner.

As a part of the consideration for this deed, the grantees assume and agree to pay a F. H. A. mortgage executed to the Aiken Loan and Security Company by Henry C. Burke in the original sum of \$6,600 and recorded in the R.M.C. Office for Greenville County in Mortgage Book 401 at page 247, said assumption to date from August 1, 1950, at which time the balance due was \$6,509.19.
