to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Vance R. Bettis and Lucy B. Bettis, their heirs and assigns forever,

All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 42, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Bradley Boulevard at the joint front corner of Lots Nos. 41 and 42 and running thence with the joint line of said lots S 37-34 E. 175 feet to an iron pin on the Northern side of a 20 foot alley; thence with said alley N 52-26 E 75 feet to an iron pin, joint rear corner of lot Nos. 42 and 43; thence with the joint line of said lots N 37-34 W. 175 feet to an iron pin on Bradley Boulevard; thence with said Boulevard S 52-26 W. 75 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
