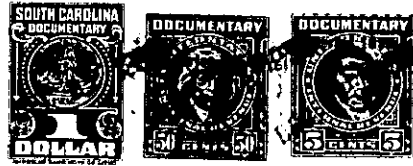

Davis, and his heirs and assigns forever, all of that certain piece, parcel or tract of land situate, lying and being in said State and County, Highland Township, and having the following metes and bounds:-

BEGINNING on a large rock, Moon Corner, and runs thence N. 67 E .3.00 to road center; thence down said road S. 44 E. 12.79 chs., to a point in road; thence S. 35 E. 2.10 chs., to a point in road and on Mitchell line; thence S. 80 1/2 W. 17.37 chs., to a stone; thence N. 20 1/2 E. 13.40 chs. to the beginning corner and containing twelve and one-half (12.50) acres, more or less, and bounded by lands of Moon Estate, Heath and I.F.
