Know All Men by These Presents:

That R. K. Taylor and R. K. Taylor, Jr. in the State aforesaid, in consideration of the sum of TEN & NO/100 (\$10.00) DOLLARS and other valuable consideration, to the grantor(s) in hand paid at and before the sealing of these presents by the grantees (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said CARLOS WINFRED BURRELL:

All that certain piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina on the Northern side of Dove Lane in a Subdivision known as Super Highway Home Sites, being known and designated as Lot No. 169 of said Subdivision, and being described according to a plat of Super Highway Home Sites recorded in the R.M.C. Office for Greenville County in Plat Book "P" at Page 53, and having, according to said plat, the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the Northern side of Dove Lane at the joint front corner of Lots Nos. 168 and 169, and running thence along the common line of said Lots N. 2-15 W. 202.5 feet to an iron pin on the Southern side of Warehouse Court; thence along the Southern side of Warehouse Court N. 65-32 E. 8J feet to an iron pin, the joint rear corner of Lots 169 and 171; thence along the common line of said Lots S. 24-26 E. 70 feet to an iron pin, the joint corner of Lots Nos. 169, 170 and 171; thence along the common line of Lots Nos. 169 and 170 S. 6-09 W. 174.4 feet to an iron pin on the Northern side of Dove Lane; thence along the Northern side of Dove Lane N. 88-42 W. 75 feet to an iron pin, the beginning corner.

The above described property is conveyed subject to restrictive covenants applicable to Super Highway Home Sites which are recorded in the RMC Office for Greenville County in Deed Volume 291 at Page 369.

This property is also conveyed subject to such easements and rights-of-way as may appear of record.
