to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Evelyn L. Waldrep, her heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the Southwest side of Courtney Circle, east of the Old Buncombe Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot '21, on plat of Casa Loma Estates, made by Piedmont Engineering Service, in October 1947, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", at page 65, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Courtney Circle, at joint front corner of Lots 20 and 21, and running thence along the line of Lot 20, S 31-34 W 136.7 feet to an iron pin; thence S 67-05 E 131.4 feet to an iron pin; thence with the line of Lot 22, N 1-58 E 147.8 feet to an iron pin on the Southwest side of Courtney Circle; thence along the Southwest side of Courtney Circle, following the curve thereof (the chord being N 68-07 E 57.8 feet) to the point of beginning.
