Sweet, her Heirs and Assigns forever, all those two certain pieces, parcels or lots of land in Paris Mountain Township, Greenville County, State of South Carolina, being known and designated as lots Nos. 136 and 137 on a Map of Avalon Estates, recorded in the RMC Office for Greenville County, in Plat Book "S", page 89, and having according to said Plat, the following metes and bounds, to-wit, said lots being combined and described as a whole:

BEGINNING at an iron pin on the North side of Crestview Drive, joint corner of lots Nos. 137 and 138, and running thence with line of lot No. 138, N.48-42 W., 221.6 feet to an iron pin in Brock Branch; thence with said Branch, N.39-58 E., 65 feet to an iron pin, joint corner of lots Nos. 135 and 136; thence with line of lot No. 135, S. 48-42 E., 223.3 feet to an iron pin on the North side of Crestview Drive; thence with Crestview Drive, S. 41-18 W., 65 feet to an iron pin, the beginning corner.

This property is conveyed subject to the following restrictions: Property is conveyed for residential purposes only; no residence shall be erected on said lot nearer than 25 feet to Crestview Drive; no residence costing less than \$5,000.00 shall be erected on said lot; said property shall not be sold, rented or otherwise disposed of to any negro or person or African descent.
