Know All Men by These Presents:

That I, W. C. Ledbetter, in the State aforesaid, in consideration of the sum of FIVE HUNDRED AND 00/100----- DOLLARS, (\$500.00), to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Charleston & Western Carolina Railway Company

ALL That piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being on the northwest side of Johnson Street, being known and designated as Lot No. 128 on plat of East Lynne Addition made by Dalton & Neves, Engineers, May, 1933, recorded in the R. M. C. office in Plat Book H, at Page 220, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING At an iron pin on the northwest side of Johnson Street at the joint front corner of Lots 127 and 128 and running thence with line of Lot 127, N. 61-10 W. 100 feet to an iron pin in the line of Lot 126; thence with the line of Lot 126, N. 28-50 E. 93.3 feet to an iron pin on the southwest edge of Ridgeway Drive; thence with the southwest edge of Ridgeway Drive, S. 45-15 E. 104.4 feet to a point where said Ridgeway Drive intersects with Johnson Street; thence along the northwest edge of Johnson Street S. 28-50 W. 64.7 feet to the beginning corner.

This property is conveyed subject to the following building restrictions:

- 1. The lot herein conveyed shall never be sold, rented, used or disposed of to negroes or persons of African descent.
2. No residence shall be erected on said property costing less than \$1,000.00.
3. The building line as shown on the recorded plat above referred to and also all of the restrictions shown on said plat are to be strictly adhered to.

Being the same property conveyed to me by B. H. Trammell by deed dated March 29 1948, and recorded in the office of the R. M. C. for Greenville County in Deed Book 401, Page 345.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its successors Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
