Know All Men by These Presents:

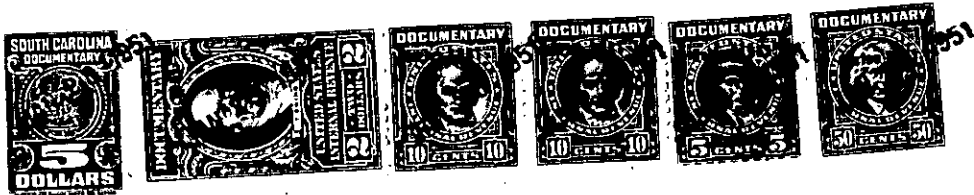
That We, Roy L. Garrett and Evelyn Garrett, in the State aforesaid,

Julius Franklin Eades and Nora Elizabeth Holliday Eades, their heirs and assigns: All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, located on the South east side of Hard surfaced road in the Town of Mauldin, S. C., adjoining lands now or formerly owned by W. A. Wilson and Jesse A. Fowler, being shown as the two front lots on a plat of Survey made by W. J. Riddle, Surveyor, on Dec. 4, 1950 and being more fully described as follows:

BEGINNING at a point in center of Hard Surfaced road, joint corner with lot now or formerly owned by W. A. Wilson, and running thence S. 24-45 E. 209.5 ft. to stake, corner of lot now owned by W. A. Wilson; thence along Wilson line S. 75-15 W. 104.8 ft. to stake on Fowler line; thence with Fowler line N. 24-45 W. 209.5 ft. to point in center of Hard Surfaced road; thence along said road N. 75-15 E. 104.8 ft. to the beginning corner.
