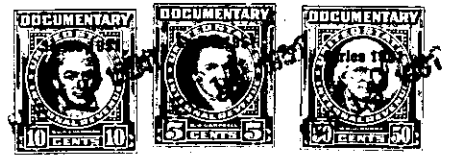
ROY V. TUCKER and ROSA LEA TUCKER, their heirs and assigns forever.
