Green and Doris H. Green and their heirs and assigns:

All of that parcel or lot of land in Chick Springs Township, Greenville County, South Carolina, in the City of Greer, lying on the south side of Mountain View Avenue, near the U. S. Super Highway No. 29 and south therefrom, being designated as Lot No. 28 on a plat of property made for W. Dennis Smith and H. J. Waters by H. S. Brockman, Surveyor, dated June 8, 1950, recorded in the R. M. C. Office for Greenville County, and having the following courses and distances:

Beginning on a stake on the southern edge of Mountain View Avenue, the joint corner of Lots Nos. 27 and 28 and runs thence with the common line of these Lots S. 8.35 W. 154 feet to a stake; thence S. 77.15 E. 70 feet to a stake, joint corner of Lots Nos. 28 and 29; thence with the common line of Lots Nos. 28 and 29 N. 8.35 E. 157.9 feet to a stake on the south side of Mountain View Avenue; thence therewith N. 81.25 W. 70 feet to the beginning corner, being all of that property as conveyed to me by C. H. Roe, et al by deed dated October 25, 1950, recorded in the R.M.C. Office for Greenville County in Deed Book 423, at page 49.
