That I, L. M. Cox, in the State aforesaid, in consideration of the sum of Twenty-and No/100 (\$20.00)-----DOLLARS.

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William M. Cox, his heirs and assigns, forever:

All that certain piece, parcel or tract of land situate on the Northwest side of a county road known as the Mauldin-Pelham Road, about three miles North-east of the Town of Mauldin, in Butler Township; in Greenville County, State of South Carolina, containing 0.17 acres, according to a survey made by R. E. Hiller, Surveyor, March 17, 1951, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest edge of the said Mauldin-Pelham Road, at corner of property of Mrs. Johnnie Green, and running thence S 52-00 W 201.3 feet to an iron pin in line of property of F. J. Marler; thence with the Marler line, S 31-30 E 76 feet to a point in the center of the said Mauldin-Pelham Road; thence with the Mauldin-Pelham Road, N 32-15 E 221.5 feet to the beginning corner.

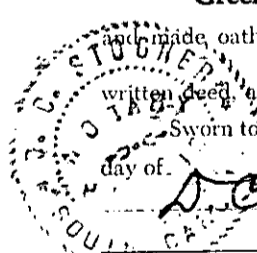

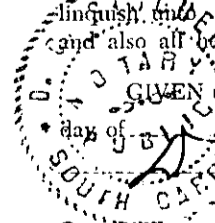
