All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot Nos. 19 and 20, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

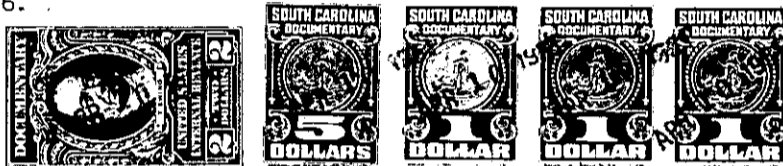
BEGINNING at an iron pin on the Northeastern intersection of U. S. Super Highway No. 29 and Beverly Lane, said pin being on the Northern side of said Super Highway and the Eastern side of Beverly Lane and running thence with Beverly Lane N37-34W 200 feet to an iron pin on the Southern side of a 20 foot alley; thence with said alley N52-26E 200 feet to an iron pin at joint rear corner of Lot Nos. 18 and 19; thence with the joint line of said lots S37-34E 200 feet to an iron pin on the Northern side of said Super Highway; thence with said Super Highway S52-26W 200 feet to the point of beginning and being Lot Nos. 19 and 20.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
