in consideration of the sum of Twenty-Three Hundred, Seventy-Five and no/100 DOLLARS,

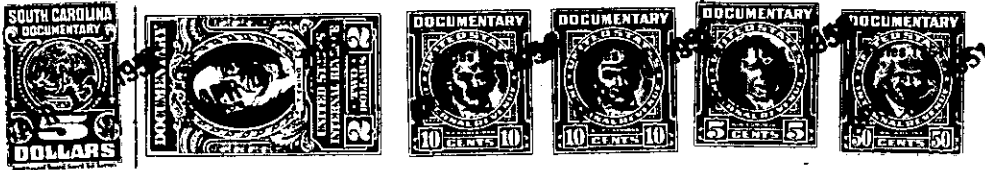
