M. C. Office for said Greenville County. Said lot has a frontage on the South side of Hampton Circle of one hundred feet (100') and has the following metes and bounds:

BEGINNING at a pin on the south side of Hampton Circle at the corner of Lot 28; thence with the south side of Hampton Circle N. 43 W. 100 feet to pin on south side of Hampton Circle at the corner of Lot 30; thence with Lot 30, S. 47 E. 166.2 feet to a pin on the LaBoon line; thence with LaBoon line S. 36-21 W. 100.7 feet to rear corner of Lot 28; thence with Lot 28, N. 47 W. 177.9 feet to the beginning corner. This is a part of the land conveyed to the Grantor herein by Earle R. Stall by deed recorded in Deed Book 432, page 349.

Said lot shall be used for residence purposes only, and no dwelling house shall be not less than 35 feet from street line and contain not less than 900 square feet ground floor area exclusive of porches, and to cost not less than \$7500.00
