Dickerson, his heirs and assigns, forever:

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being on the South side of Rogers Avenue, being known and designated as the major portion of Lot 25 of the property of $^{\rm B}$. E. Geer as shown on a plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "G", Page 237, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the South side of Rogers Avenue, joint front corner of Lots 24 and 25, and running thence S. 5-50 E. 150.5 feet to a point in the rear line of Lot #5, and at the joint rear corner of Lots 24 and 25; thence along the rear line of Lot #5, S. 83-55 W. 49 feet to an iron pin located one foot East of the Southwestern corner of Lot 25; thence along a line one foot East of the Eastern line of Lots 4 and 26, N. 5-50 W. 150.5 feet to an iron pin on the South side of Rogers Avenue, which iron pin is one foot East of the joint front corner of Lots 25 and 26; thence along the Southern side of Rogers Avenue, N. 83-55 E. 49 feet to the beginning corner.
