Shelton J. Rimer, his heirs and assigns,

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, being known and designated as Lot No. 15, Block "J", according to Plat of Property of Fair Heights, which is recorded in the R.M.C. Office for Greenville County in Plat Book "F", at Page 257, and having the following metes and bounds, to-wit:

BEGINNING at a point on the Southeast side of Fairview Avenue at the joint corner of Lots 15 and 16 and running thence along the line of Lot 16, S.58-40 E., 133.1 feet to a point at the joint rear corner of Lots 21 and 22; thence along the rear line of Lot 22, N.31-20 E., 50 feet to a point at joint rear corner of Lots 22 and 23; thence along the dividing line of Lots 14 and 15, N.58-40 W., 132.8 feet to a point on the Southeast side of Fairview Avenue; thence along Fairview Avenue, S.31-47 W., 50 feet to the beginning corner.
