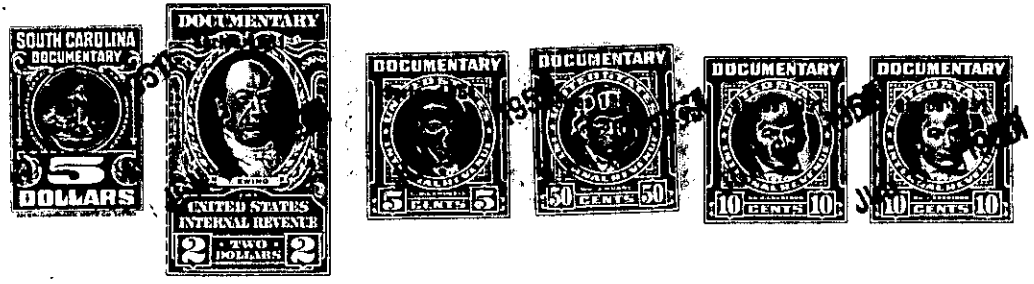

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these
presents do grant, bargain, sell and release unto the said Alvin W. Henderson and/or Elizabeth
S. Henderson, their heirs and assigns,

all that piece, parcel or lot of land in Bates Township, Greenville
County, State of South Carolina having the following metes and bounds and courses
and distances:

BEGINNING on a stake in the road on F. H. Earl line and running
thence with said line N. 36.00 W. 1497 feet to a stake in the branch;
thence up the meandors of said branch as the line S. 53.45 W. 142 feet
to a bend; thence S. 41.45 W. 101 feet to a bend; thence S. 50.00 W.
101 feet to a bend; thence S. 34.30 W. 101 feet to a bend; thence S.
18.00 W. 70 feet to a bend; thence S. 4.30 W. 170 feet to a bend;
thence S. 27.00 W. 85 feet to a bend; thence S. 3.00 E. 265 feet to a
bend; thence S. 80.00 W. 50 feet to a bend; thence S. 25.00 E. 290
feet to a bend; thence S. 13.00 E. 150 feet to a bend; thence S. 33.00
W. 180 feet to a stake in the branch; thence S. 14.30 W. 59 feet to
a large sweet-gum; thence S. 30.00 E. 565 feet to a stake in the road;
thence with the road as the line N. 59.00 E. 83 feet to a bend in
said road; thence N. 50.30 E. 101 feet to a bend in the said road;
thence N. 61.00 E. 253 feet to a bend; thence N. 47.45 E. 795 feet
to a stake in the above said Earl line, the beginning corner. Contain-
