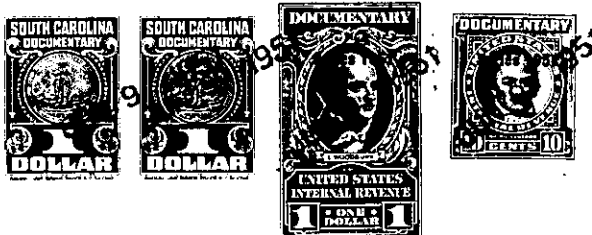

Grant, her heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, on the Southeast side of Aiken Street, in the City of Greenville, being the rear portion of lot 8 of Block C, as shown on plat of Melville Land Company recorded in Plat Book A at Page 97, and according to survey made by J.C. Hill on June 8, 1951, is described as follows:

BEGINNING at a stake on the Southeast side of Aiken Street 81 feet South from Burdette Street and running thence with the Southeast side of said street, S. 43-00 W. 69 feet to stake at corner of lot 9; thence with line of said lot, S. 47-00 E. 50 feet to a stake at corner of lot 7; thence with line of said lot, N. 43-00 E. 64 feet to a stake; thence in a Northwesterly direction 50.2 feet to the point of beginning.
