

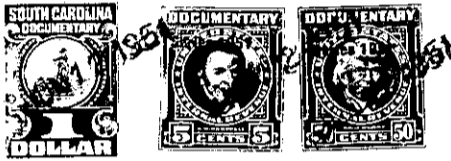

Stewart, his heirs or assigns:- All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, located on the Southeast side of Perry Street extension near the Town limits of Simpsonville, S. C., being shown as lot # 2 on a plat of property of F. A. Hunter as made by W. J. Riddle, Surveyor, on December 1950, and having according to said plat, the following metes and bounds, to-wit:-
