to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Donna M. Stelling, her heirs and assigns, forever:

All those pieces, parcels or lots of land situate, lying and being in the City of Greenville, Greenville Township, Greenville County, State of South Carolina on the South side of Heather Way and being known and designated as Lots #137, 138 and the major portion of Lot #139 as shown on a plat by Dalton & Neves of a subdivision known as Marshall Forest prepared in October, 1928 and recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book H, Page 133-134 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an ironpin on the South side of Heather Way, joint corner of Lots #136 and 137 and running thence with the joint lines of said lots S. 33-58 W. 305.8 feet to an iron pin on the North side of a 10 foot reservation for utilities; thence with the Northern line of said reservation S. 39-22 E. 70.7 feet to an iron pin at the corner of Lot #140; thence N. 35-38 E. 349.1 feet to an iron pin on the South side of Heather Way; thence with the line of Heather Way N. 73-27 W. 83.8 feet to the beginning corner.
