That I, O. S. McCarter in the State aforesaid, in consideration of the sum of One (\$1.00)----- DOLLARS, (and the love and affection which I bear for my children)----- to the grantor(♂) in hand paid at and before the sealing of these presents by the grantee(♀) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Josephine McCarter Johnson

All those two tracts in Greenville County, South Carolina, in School District 10-A (and 9-C) and having the following aggregate metes and bounds:

BEGINNING at an iron pin in Crestwood Drive, joint corner of tracts 3 and 4, and thence running N. 57-41 W. 427.2 feet to an iron pin in the Finson line; thence N. 40-08 E. 290.0 feet to an iron pin in the Salzman line; thence S. 38-37 E. 328.2 feet to an iron pin in Crestwood Drive; thence along Crestwood Drive N. 23-00 E. 374.6 feet to an iron pin at the corner of tract No. 1; thence S. 57-30 E. 55 feet to an iron pin; thence S. 23-00 W. 376.6 feet to an iron pin in the line of tract No. 6; thence E. 38-37 W. 55 feet to an iron pin in Crestwood Drive; thence along Crestwood Drive S. 7-12 W. 185 feet to the beginning.

These tracts are shown as No. 2 containing 0.43 acres and No. 3 containing 1.73 acres on a plat made by J. Mac Richardson in April 1950, revised in March 1951.

Reserving, however, a life estate in said property unto the grantor during his life-time and thereafter unto Mrs. Nellie McCarter during her life-time

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee, hereinabove named, and her Heirs and Assigns forever. Subject to the life estates above reserved.

And the grantor(♂) do(es) hereby bind the grantor(♂) and the grantor's(♂) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(♀) hereinabove named, and the grantee's(♀) Heirs and Assigns against the grantor(♂), and the grantor's(♂) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
