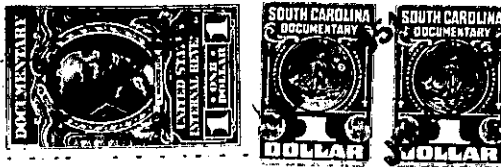

Know All Men by These Presents:

That I, Owen B. Helligan, Jr., in the State aforesaid, in consideration of the sum of Eight Hundred Twenty-five (\$825.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. L. Tinsley, his heirs and assigns forever,

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, and being known and designated as Lot No. 52 of a subdivision known as Vista Hills, a plat of which is of record in the R. H. C. Office for Greenville County in Plat Book F at page 149, and having the following notes and bounds, to-wit:

BEGINNING at a point on the Eastern side of Kent Lane, said point being 10 feet North of the Northeast Intersection of Kent Lane with County (Gilfillin) Road, and running thence N. 89-10 E. 175 feet to a point at the Joint rear corner of Lots 51 and 52; thence N. 1-50 W. 70 feet to a point at the Joint rear corner of Lots 52 and 53; thence S. 89-10 W. 175 feet to a point on the Eastern side of Kent Lane at the Joint front corner of Lots 52 and 53; thence with the Eastern side of Kent Lane, S. 1-50 E. 70 feet to the point of beginning.

Being the same property conveyed to me by Julius P. Thrasher by deed dated October 17, 1950 and recorded in the Office of the R. H. C. for Greenville County in Deed Book 421, at page 371.

This deed is executed subject to existing and recorded restrictions and rights-of-way.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
