All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, Butler Township, county of Greenville, state of South Carolina, being known and designated as lot No. 69, on plat of College Heights, made by Dalton & Neves, Engineers, recorded in the R. M. C. Office for Greenville County in plat book P, page 75 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin at the southwest corner of Griffin Drive and Columbia Circle, and running thence with the south side of Columbia Circle, S. 56-50 W. 150 feet to an iron pin in line of lot No. 68; thence with the line of said lot S. 33-10 E. 75 feet to an iron pin corner of lot No. 70; thence with the line of said lot N. 56-50 E. 150 feet to an iron pin on the west side of said drive N. 33-10 W. 75 feet to the beginning corner.
