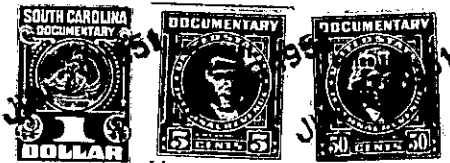
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said O. O. Freeman and Pearl Freeman their Heirs and Assigns forever, all that certain piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, being know and designated as lot No. 49 on a map of Avalon Estates, recorded in the RMC Office for Greenville County in Plat Book "S", page 89, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Crestview Drive, joint corner of lots Nos. 48 and 49, and running thence with line of lot No. 48, N. 64-24 E., 185.6 feet to an iron pin in rear line of lot No. 92; thence with rear line of lot No. 92, S. 0-23 E., 30 feet to an iron pin; thence with rear line of lot No. 91, S. 9-44 E., 57.06 feet to an iron pin, joint corner of lots Nos. 49 and 50; Thence with line of lot No. 50, S. 72-18 W., 162.4 feet to an iron pin on the East side of Crestview Drive; thence with Crestview Drive, N. 22-31 W., 60 feet to an iron pin, the beginning corner.

This property is conveyed subject to the following restrictions and conditions; This property to be used for residential purposes only; no residence costing less than \$5,000.00 shall be erected on said lot; no building shall be erected on said lot nearer than 25 feet to Crestview Drive; said lot shall not be sold, rented or otherwise disposed of to any negro or person of African descent.
