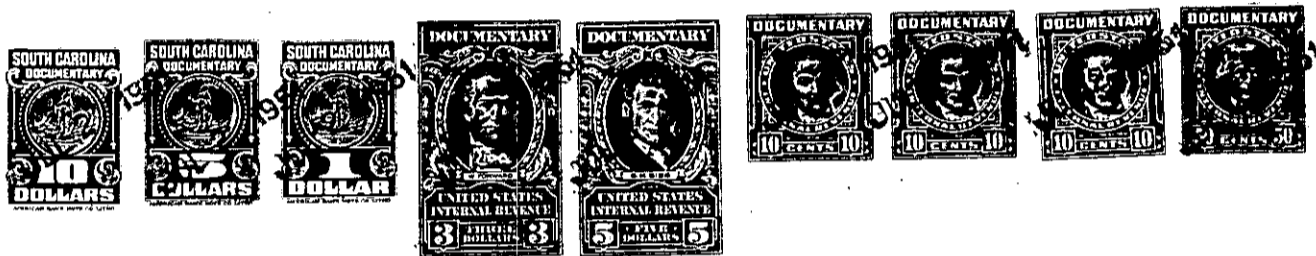
Know All Men by These Presents:

All that certain piece, parcel or lot of land in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 53 on plat of College Heights made by Dalton & Neves, Engineers, August 1946, recorded in the R. M. C. Office for Greenville County, in plat book "P" page 75, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southeast side of Princeton Avenue, the joint corner of lots 50 & 53, and running thence with the joint line of said lots S. 33-10 E. 175 feet to an iron pin rear corner of lot No. 61; thence with the rear line of said lot N. 56-50 E. 75 feet to corner of lot No. 54; thence with the line of said lot N. 33-10 W. 175 feet to an iron pin on the southeast side of Princeton Avenue; thence with the southeast side of said street S. 56-50 W. 75 feet to the beginning corner.
