All of that parcel or lot of land in the City of Greer, in Chick Springs Township of Greenville County, South Carolina, lying on the South side of the Brushy Creek Road, being the eastern one-half of lot No. 25, which lot is shown on a plat of property made for the Mrs. E.A. Wood Estate by H.S. Brockman, Surveyor, dated June 22, 1935, and having the following courses and distances: BEGINNING on an iron pin on the South side of Brushy Creek Road, joint front corner of lots Nos. 22 and 25 on said plat, and runs thence S. 76.00 W. 35 feet to a point, said point being equi-distant of the two front corners of lot No. 25; thence a new line equally dividing lot No. 25 S. 11.56 E. 170 feet to a point on rear line of lot No. 24, said point being equi-distant of the two rear corners of lot No. 25; thence N. 76.00 E. 35 feet to an iron pin, joint rear corner of lots Nos. 22 and 25; thence with the common line of these lots N. 11.56 W. 170 feet to the beginning corner, and being a portion of that lot conveyed to me by O.D.
