W. Poe Mfg. Co., Greenville, S. C." made by Dalton & Neves, July, 1950 and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book Y, pages 26 to 31, inclusive. BEGINNING at an iron pin on the North side of Sixth Avenue at the joint front corner Lots Nos. 213 and 214, said iron pin being located 151.6 feet from the Northeast corner of the intersection of Sixth Avenue and A Street and running thence S. 41-27 E. 69 feet to an iron pin on an alley; thence N. 48-58 E. 70.5 feet to an iron pin in the line of Lot No. 242; thence N. 52-35 W. 75 feet to an iron pin at the joint rear corner Lots Nos. 243 and 214 and running thence S. 44-34 W. 56.1 feet to an iron pin, the point of beginning.
