Know All Men by These Presents:

That I, Henry P. Willimon in the State aforesaid,
in consideration of the sum of Forty Nine & 50/100-----(\$49.50)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Bender Cooley and Sue Cooley, their heirs and assigns forever:

ALL that piece, parcel or lot of land being known and designated as Lot No. 111 A of Pine Forest as shown by a Plat thereof, made by Madison H. Woodward, Engineer; said Lot having the courses, distances, metes and bounds to-wit:

BEGINNING at an iron pin on corner of Lot No. 111 located on South Pine Lake Circle Street and running thence along the line of Lot No. 111, N. 19-37 E. to iron pin at back corner of Lot No. 111; thence N. 72-06 W. 75.5 feet to iron pin on West Pine Lake Circle Street; thence with the line of West Pine Lake Circle Street S. 20-13 W. 130 feet to iron pin at intersection of West Pine Lake Circle and South Pine Lake Circle Streets; thence along the line of said South Pine Lake Circle Street S. 72-06 E. 76.6 feet to point of beginning.

THAT the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent. No residence to cost less than Two Thousand (\$2,000.00) Dollars shall be erected on said lot, and no residence shall be erected on said lot nearer than twenty-five (25) feet to the front line, and no residence shall be built on any lot unless said lot has fifty (50) feet, or more, frontage.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
