BEGINNING at a nail and cap in the center of the Fork Shoals Road, and running thence with said road, N. 27-30 E. 173.5 feet; thence continuing with said road, N. 17-45 E. 171.8 feet; thence continuing with said road, N. 8-40 E. 172.1 feet to a nail and cap in center of said road; thence S. 77-50 E. 831.6 feet to a stone; thence S. 69-40 E. 867.5 feet to iron pin; thence S. 11-40 W. 10 feet to a white oak near branch; thence crossing the branch, S. 75-30 E. 662.5 feet to a stone; thence S. 11-40 W. 367 feet to a stone; thence N. 78-35 W. 2418 feet crossing a branch to the point of beginning, containing 22.39 acres, more or less.

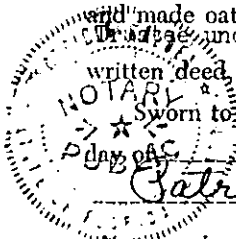
