T. Cason, and Margaret L. Cason, their heirs and assigns:

All that lot of land in Greenville County, State of South Carolina, in the City of Greenville, being known as lot No. 13, of Block M as shown on Plat recorded in Plat Book C, at Page 176, and being more particularly described as follows:

BEGINNING at an iron pin on the Western line of Grove Road, 220 feet from the intersection of Southern line of Augusta Road with the western line of Grove Road, and running thence N. 48-22 W. 180.4 feet along line of lot No. 14; thence along the rear line of lots Nos. 6 and 7, 50 feet; thence S. 48-22 E. 181 feet, more or less, along the Southwestern boundary of property now or formerly owned by Bonnie B. 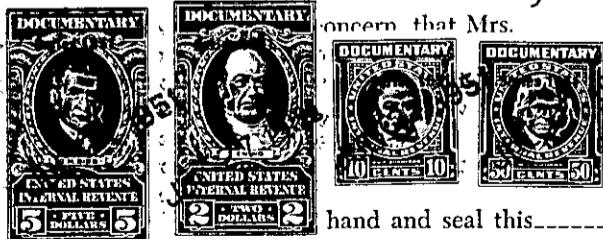
