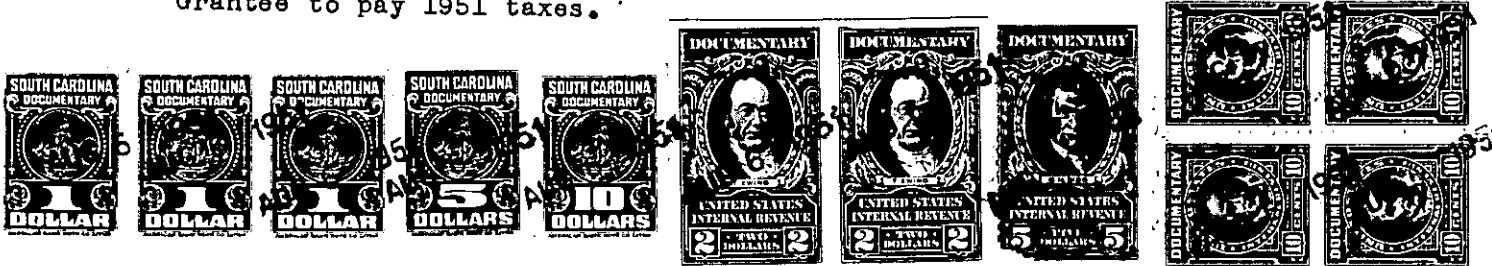
All that lot of land with the improvements thereon situate on the North side of Valley View Lane, near the City of Greenville, in Greenville County, State of South Carolina, shown as Lot 56 on plat of Sylvan Hills, made by Piedmont Engineering Service, June 1948, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", at page 103, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Valley View Lane, at joint front corner of Lots 55 and 56, and running thence along the line of Lot 55, N 5-36 W 150 feet to an iron pin; thence N 84-24 E 70 feet to an iron pin; thence with the line of Lot 57, S 5-36 E 150 feet to an iron pin on the North side of Valley View Lane; thence along the North side of Valley View Lane, S 84-24 W 70 feet to the beginning corner.
