to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ernest D. Stuart, his heirs and assigns forever:

All those pieces, parcels or lots of land in Chick Springs Township, Greenville County, State of South Carolina, lying and being on the Eastern side of Rose Garden Street and being known and designated as Lots 42, 43 and 44 of Block D of Beuna Vista, a sub-division, as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book W, Pages 11 and 29, and being more particularly described according to a plat by W. N. Willis dated May 8th, 1951, as follows:

BEGINNING at an iron pin on the Eastern side of Rose Garden Street, joint front corner Lots 41 and 42 and running thence; with the joint line of lots 41 and 42, N. 80-17 E. 150 feet to an iron pin, joint corner lots 23, 24, 41 and 42; thence along the line of lots 24, 25 and 26, S. 9-43 E. 105 feet to an iron pin, rear corner lots 26, 27, 44 and 45; thence with the joint line of lots 44 and 45, S. 80-17 W. 150 feet to an iron pin on the Eastern side of Rose Garden Street, joint front corner lots 44 and 45; thence along the Eastern side of Rose Garden Street, N. 9-43 W. 105 feet to the beginning corner.

The above is the same property conveyed to me by Robert J. Edwards, et al by deed dated November 1, 1950 and recorded in the R. M. C. Office for Greenville County in Deed Book 422, Page 331.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and Heirs and Assigns forever.

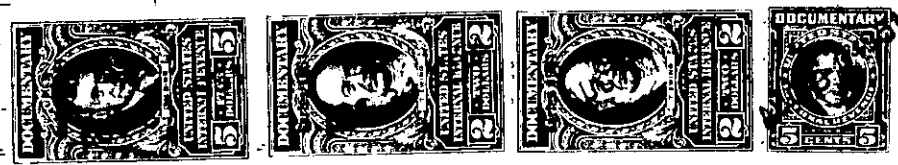
