

Location 10 Briar St; City Plat Book Page 91; Block 3; Lot 1.

Property located on the northwest side of Briar St. and south of Carson Alley, with frontage of 50' more or less on Briar St. and an approximate depth of 100' on Carson Alley. Property on the corner of these two streets.

Location 315-319 Sullivan St; City Plat Book Page 95; Block 3; Lot 20 and 21A:

Property located on the southwest side of Sullivan St. with a frontage of 154' more or less, and with an approximate depth of 240'. Also rearage of approximately 81.8'.

Location 501-505 Jenkins St; City Plat Book Page 85; Block 3; Lot 1.

Property located on the southeastern corner of Jenkins St. and west of Putnam St. Frontage of 158.2' more or less on Jenkins St. and also 226' more or less on Putnam St. Approximate depth 200.5' west and 41' south. Irregular lines. Street numbers on Putnam St. are 2, 4, 6, 8, 10.

Location 201 Ansel St. (St. John St.); City Plat Book Page 87; Block 3; Lot 13:

Property located on the northwest corner of Robins St. and St. John, with a frontage of 52.3' more or less on St. John St., and a depth of 100' on Robins St. Property is on the corner of the two streets.

Location 305 Ansel St. (St. John); City Plat Book Page 82; Block 5; Lot 2.

Property located on the corner of the southwest side of St. John and east of Calvary St., with a frontage of 72' more or less on St. John, and with approximate depth of 132.4' on Calvary St.

Location 411 Railroad St; City Plat Book Page 26; Block 3; Lot 10.

Property located with a frontage on the Southern Railroad consisting of 116' more or less, and with an approximate depth of 247'. Property is triangular.

Location 403 Cook St; City Plat Book Page 26; Block 4; Lot 4.

Property located on the southwest side of Cook St. with a frontage of 53' on Cook St., and an approximate depth of 122.8' and 20' more or less located on South Railroad St.

Location 9 Manley Alley; City Plat Book Page 41; Block 2; Lot 26.

Property located on the northwest side of Manley Alley with a frontage of 69' more or less, and an approximate depth of 94' west. Property is irregular in shape.

Location 116 Birnie St; City Plat Book Page 56; Block 3; Lot 15.

Property located on the north side of W. Birnie St., this frontage amounting to 52' more or less, with a depth of approximately 214'.

Location Piney Mtn. land, 2 $\frac{1}{2}$  acres, Chick Springs Township; County Plat Book Page 183; Block 1; Lot 5.

Beginning at a point on P & N Railroad, this lot starts 71.3' more or less to the north of this point. It has a frontage of 352' on an unnamed road, and a depth of approximately 236'. The unnamed street proceeding northwest intersects a road that goes to the southwest and intersects Worley Road. Property is listed as 1-P & N Railway. WWW 170 (1-4-08). This property was once the old Simon Hymes place and is bounded by lands in 1908 of Peter Ligon, John Miles, and Dr. E. Stone.
