Davis, his attorney in fact, herein called grantors, in consideration of mutual partition deeds being executed by the various parties each to the other, execution and delivery of said deeds to us being hereby acknowledged at the time of the sealing of these presents, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto Louise M. Davis (whose full and correct name is Annie Louise Miller Davis, some times in the records of the estates involved erroneously called Louise A. Davis), herein called grantee, all our right, title and interest in and to the following described property located in said state and county which is designated as follows:

Location 202 N. Markley St; City Plat Book Page 74; Block 1; Lot 4.

The property is located on the E. side of N. Markley, with a frontage of 60' more or less, and a depth of approximately 119'. Also a rearage of 54' more or less.

Location 204, 206, 208 N. Markley St; City Plat Book Page 74; Block 1; Lot 5.

Property located on the east side of N. Markley, frontage 122' more or less, depth of approximately 94'. Also a rearage of approximately 149.5'.

Location 1021 E. North St; City Plat Book Page 39; Block 6; Lot 43.

Property located on the north side of E. North St. with a frontage of 68.1' more or less, and with an approximate depth of 101'. Also a rearage of approximately 71'.

Location 1023 E. North St; City Plat Book Page 39; Block 6; Lot 44.

Property located on the north side of E. North, with a frontage of 61.9' more or less, and an approximate depth of 138'. Also a rearage of 72'.

Location Queen St. & Packs Alley; City Plat Book Pg. 76; Block 3; Lot 5. Co. Plat Book Page 123; Block 9; Lot 3 and 4.

76-3-5: Property located on the north side of Pack Alley and north of Queen St., with a frontage of 85.1' more or less, and a depth of approximately 244'. Property is on the corner of these two streets.

123-9-3: Property located on the north side of Pack Alley and north of Queen St. with a frontage on Pack Alley of 325' more or less, with an approximate depth of 113'. Property listed No. 1 Packs Alley.

123-9-4: Property located on the south side of Pack Alley and north of Queen St., with a frontage on Pack Alley of 296' more or less, and approximate depth on Queen St. of 193', and an approximate depth on Chappell Alley of 199'. Also a rearage of 167'. Listed No. 1 Packs Alley.
