to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James William Davis, his heirs and assigns, forever:

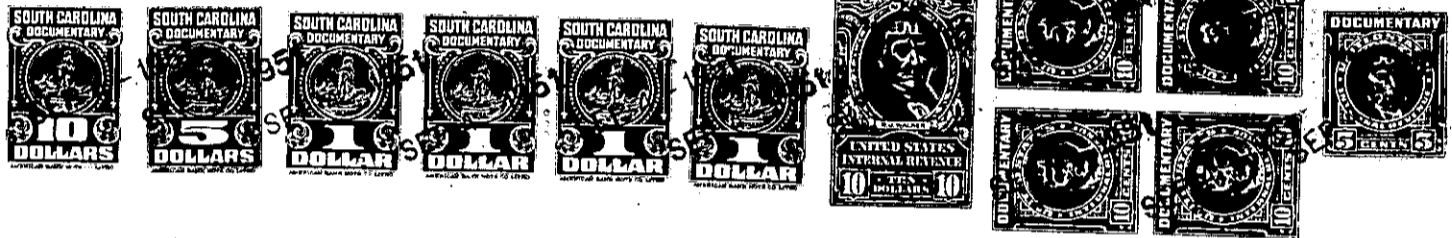
All that lot of land with the improvements thereon situate on the North side of Waters Avenue, in the City of Greenville, in Greenville County, State of South Carolina, shown as Lot 7 on plat of Pickwick Heights, made by Dalton & Neves, Engineers, March 1950, recorded in the R. M. C. Office for Greenville County, S.C., in Plat Book "X", at page 141, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Waters Avenue, at joint front corner of Lots 6 and 7, and running thence along the line of Lot 6, N 24-53 W 132 feet to an iron pin; thence N 65-07 E 60 feet to an iron pin; thence with the line of Lots 8, S 24-53 E 132 feet to an iron pin on the North side of Waters Avenue; thence along the North side of Waters Avenue, S 65-07 W 60 feet to the beginning corner.

This is a portion of that property conveyed to me by deed of E. Inman, Master, dated February 21, 1950, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 403, at page 161.
